TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") dated as of February 28, 2005 ("Effective Date"), is made and entered into by and between Teleflex Incorporated ("Assignor") and Sermatech International Incorporated, a Pennsylvania corporation ("Assignee").

WHEREAS, pursuant to the Purchase Agreement between Assignor and ACP Sermatech Acquisition Corp. ("Acquisition Corp.") dated February 28, 2005 (the "Agreement"), Assignor has agreed to sell, and Acquisition Corp. has agreed to purchase, the assets, properties and rights pertaining to the Business (as defined in the Agreement) including without limitation all of the outstanding capital stock (or equity equivalents) of Assignee;

WHEREAS, Assignor owns the right, title and interest in and to those United States trademark registrations and applications for trademark registrations identified and set forth on Schedules A and B respectively, and the foreign trademark registrations and applications for trademark registrations identified and set forth on Schedules C and D respectively (collectively, the "Marks");

WHEREAS, Assignee is a successor to that part of Assignor's business to which the Marks pertain, and that business is ongoing and existing; and

WHEREAS, Assignee wishes to acquire, and Assignor wishes to assign, all of Assignor's right, title and interest in and to the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor does hereby sell, assign, transfer and set over to Assignee all of Assignor's right, title and interest in and to the Marks, for the United States and for all foreign countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.






