SHORT FORM TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT (this "Trademark Security Agreement"), dated as of April 18, 2005, is executed by each of the signatories identified on the signature pages hereto as "Luxembourg Obligations Grantors" (the "Lux Obligations Grantors") and each of the signatories identified on the signature pages hereto as "All Obligations Grantors" (the "All Obligations Grantors" and together with the Lux Obligations Grantors and any other entity that may become a party hereto as provided herein, the "Grantors"), in favor of LEHMAN COMMERCIAL PAPER INC., ("Lehman") as Collateral Agent (in such capacity, the "Collateral Agent") for the Secured Parties (as defined in the Credit Agreement referred to below).

WITNESSETH:

WHEREAS, pursuant to the Second Lien Term Loan Agreement, dated as of April 18, 2005 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), among INFOR GLOBAL SOLUTIONS AG ("Holdings"), INFOR GLOBAL SOLUTIONS TECHNOLOGY GmbH ("Swiss IPCo"), INFOR SWISS HOLDINGS GmbH ("Swiss Subco"), MAGELLAN HOLDINGS, INC. (the "U.S. Borrower") and INFOR GLOBAL SOLUTIONS EUROPEAN FINANCE, S.a r.l. (the "Lux Borrower", and together with the U.S. Borrower, collectively the "Borrowers" and each a "Borrower"), the Lenders parties thereto, LEHMAN BROTHERS INC., as Arranger, WELLS FARGO FOOTHILL, INC., as Syndication Agent and LEHMAN COMMERCIAL PAPER INC., as Administrative Agent, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth in the Credit Agreement;

WHEREAS, it is a condition precedent to the obligation of the Lenders to make their respective extensions of credit to the Borrowers under the Credit Agreement that the Grantors shall have executed and delivered to the Administrative Agent, a Guarantee and Collateral Agreement, in favor of the Collateral Agent (the "Security Agreement") to guarantee the Obligations; and

WHEREAS, the Grantors are required to execute and deliver this Trademark Security Agreement pursuant to the Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent and the Lenders to enter into the Credit Agreement and to induce the Lenders to make their respective extensions of credit to the Borrowers thereunder, each Grantor hereby agrees with the Collateral Agent, for the benefit of the Secured Parties, as follows:

Section 1. Defined Terms

Unless otherwise defined herein, terms defined in the Credit Agreement or in the Security Agreement and used herein have the meanings given to them in the Credit Agreement or the Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral

Each Grantor hereby grants to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, all of the following property now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral"), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations (as defined in the Security Agreement) of such Grantor:

- (a) all of its Trademarks included in the Collateral, including, without limitation, those referred to on Schedule 1 hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark;
- (d) to the extent not otherwise included, all Proceeds and products of any and all of the foregoing, all Supporting Obligations in respect of any of the foregoing and all collateral security and guarantees given by any Person with respect to any of the foregoing; and
- (e) all rights to sue at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment of the foregoing, including, without limitation, the right to receive all income, royalties, proceeds and damages therefrom, whether now or hereafter due or payable

Section 3. Security Agreement

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Security Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Section 4. Grantor Remains Liable

Each Grantor hereby agrees that, anything herein to the contrary notwithstanding, such Grantor shall remain liable and assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with the Trademark Collateral.

Section 5. Counterparts

This Trademark Security Agreement may be executed by one or more of the parties hereto in any number of separate counterparts (including by telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.

Section 6. Governing Law

This Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.






