RELEASE OF SECURITY INTEREST, TRADEMARKS

THIS RELEASE OF SECURITY INTEREST is effective the 25 day of April, 2005 by Huntington Technology Fund, L.P., a California limited partnership, with a business address of 19700 Fairchild Road, Suite 290, Irvine, California 92612 ("Huntington").

WITNESSETH

WHEREAS, Huntington, in a SECURITY INTEREST dated December 27, 2004 ("Trademark Security Agreement") and recorded in the Assignment Branch of the U.S. Patent & Trademark Office at Reel 003009 and frame 0482 on January 13, 2005, acquired a security interest from Datanautics, Inc. (now called Cydelity, Inc.), a Delaware corporation ("Datanautics"), in the trademark DATANAUTICS, serial no. 78/347738, filed January 5, 2004 ("Trademark");

WHEREAS, the debt, lien or other liability as set forth and discussed in the Trademark Security Agreement was and is extinguished;

NOW, THEREFORE, in exchange for good and valuable consideration, receipt of which is hereby acknowledged, Huntington agrees as follows:

Effective April 25, 2005, Huntington hereby releases, waives, resigns and disclaims any and all security interest in the Trademark, and hereby extinguishes the Trademark Security Agreement in its entirety.
