## RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is executed as of this 22<sup>nd</sup> day of October 2004, by UNION BANK for itself and each secured party to the Security Agreement (the "Lender").

WHEREAS, Gold's Gym Licensing, Inc., a corporation organized under the laws of the State of Delaware, by assignment from Gold's Gym Enterprises, Inc., with a business address of 2841 Hartland Road, Suite 402, Falls Church, Virginia 22043 (hereinafter referred to as the "Borrower"), and the Lenders entered into that certain Security Agreement dated as of December 22, 1988 (as may have been amended through the date hereof, the "Security Agreement").

WHEREAS, pursuant to the terms and conditions of the Security Agreement, Lender was granted a security interest in all of Borrower's interest in the collateral more specifically described on Exhibit A attached hereto ("Collateral").

Such Security Agreement was filed with the United States Patent and Trademark Office on January 25, 1989, and recorded against the Trademark Collateral on Reel/Frame 0633/0949.

WHEREAS, the Lender has received consideration for a full and complete release of the security interest in and liens in the Collateral, and now wishes to release such security interest and liens in the Collateral.

NOW THEREFORE, Lender represents and agrees as follows:

1. Lender hereby releases, cancels and terminates all of its right, title and interest in and to the Collateral, including its security interest in and liens on the Collateral and all other rights with respect to the Collateral, and conveys and assigns any and all right, title and interest that it may have in and to the Collateral to Borrower.

2. Lender represents that it has not exercised any of the rights with respect to the Collateral available to it under the Security Agreement. Lender represents and warrants that it has not sold, licensed, conveyed or otherwise alienated any rights in and to the Collateral, and that it has not practiced or sublicensed any of the Collateral.

3. Without limiting the generality of the foregoing, this Release is intended to and shall forever terminate the irrevocable rights in the Collateral conveyed to Lender and reconvey such rights to Borrower.

Lender agrees that hereafter it will not take any action with respect to the Collateral.

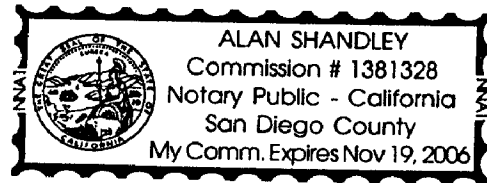
