TRADEMARK ASSIGNMENT

WHEREAS, Strouds Acquisition Corporation, a Delaware corporation ("Assignor"), is the owner of the trademark and trademark registration in the form more fully described in Exhibit A hereto (the "Mark") associated with certain specified goods (the "Goods");

WHEREAS, Assignor and Hunter Douglas Inc., a Delaware corporation ("Assignee"), have executed a Trademark Purchase Agreement;

WHEREAS, pursuant to the terms of the Trademark Purchase Agreement Assignor desires to assign and Assignee desires to receive all of Assignor's right, title and interest in and to the Mark, together with the goodwill associated therewith, with respect to the Goods.

NOW THEREFORE, effective April 15, 2003, for the consideration set forth in the Trademark Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, assigns and sets over unto Assignee, its successors and assigns, all of Assignor's entire right, title and interest in and to the Mark, with respect to the Goods in the United States of America, together with the goodwill associated therewith and symbolized by the Mark, all common law rights related thereto, all rights of registration, renewal and extension, and the right to recover for damages and profits for past infringements thereof.

Assignor agrees to execute and deliver at the request of Assignee all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may request in order to vest all of Assignor's right, title, and interest in and to the Mark in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.
