ASSIGNMENT



Assignor hereby appoints Assignee its attorney-in-fact to act in Assignor's name, place and stead to execute, deliver and record any document or instrument of assignment required in any country in which the Trademark is used, pending or issued, granting or confirming the rights granted herein, but only to the extent of those rights granted herein in connection with the Trademark.
