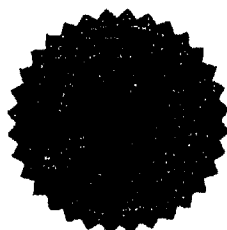

Pursuant to the provisions of Section 242 of the Delaware General Corporation Law, the undersigned, being an authorized person of the Corporation, hereby certifies and sets forth as follows:

FIRST: The name of the Corporation is RADIOVOODOO, Inc. (the "Corporation").

SECOND: The Certificate of Incorporation of the Corporation was filed by the Secretary of State on the 12th day of September, 2000.

THIRD: The Certificate of Incorporation is hereby amended to change the name of the Corporation pursuant to Section 242 of the General Corporation Law. Section "FIRST" is hereby amended as follows:

FIRST: The name of the Corporation is VOODOOVOX, INC.

FOURTH: In lieu of a meeting and vote of shareholders, the shareholders being the holders of at least a majority of all the outstanding shares of stock entitled to vote, have agreed by written consent, to the amendment above in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

FIFTH: The aforesaid amendment was duly adopted in accordance with the applicable provisions of Section 242 of the General Corporation Law of the State of Delaware.


