PLAN OF MERGER approved on September 27, 2004 by TED Licensing Corporation, which is a business corporation organized under the laws of the State of California, and by resolution adopted by its Board of Directors on said date, and approved on September 27, 2004 by Education Direct, Inc., which is a business corporation organized under the laws of the Commonwealth of Pennsylvania, and which is subject to the provisions of the Business Corporation Law of 1988 of the Commonwealth of Pennsylvania, and by resolution adopted by its Board of Directors on said date.

- 1. TED Licensing Corporation and Education Direct, Inc. shall, pursuant to the provisions of the Corporation Code of the State of California and the provisions of the Business Corporation Law of 1988 of the Commonwealth of Pennsylvania, be merged with and into a single corporation, to wit, Education Direct, Inc., which shall be the surviving corporation upon the effective date of the merger and which is sometimes hereinafter referred to as the "surviving corporation", and which shall continue to exist as said surviving corporation under its present name pursuant to the provisions of the Business Corporation Law of 1988 of the Commonwealth of Pennsylvania.
