ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record patents, applications and title thereto, to record the Trademark and title thereto as the property of the ASSIGNEE, its successors, assigns and legal representatives in accordance with the terms of this agreement.

ASSIGNOR further covenants and agrees to execute such additional documents as may be reasonably required to record ASSIGNEE as the owner of the Trademark herein assigned.
