

RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated March 24, 2005 by Harris Trust and Savings Bank, as Collateral Agent as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60690, acting as collateral agent (the "*Collateral Agent*"), and Hub Group, Inc., a Delaware corporation with its mailing address at 377 East Butterfield Road, Lombard, Illinois 60148 (the "*Debtor*"), are parties to a certain Trademark Collateral Agreement dated October 15, 2002 which was recorded in the United States Patent and Trademark Office on October 15, 2002 at Reel 002600, Frame 0164 (the "*Assignment*"), pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks and certain other property listed on Schedule A of the Assignment; and

WHEREAS, the Debtor has requested that the Collateral Agent release its security interests in such trademarks and other property and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Collateral Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Collateral Agent, all of its right, title and interest, if any, in and to:


(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) Each trademark license listed on Schedule A hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by the Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or of any trademark licensed under a trademark license listed on Schedule A or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.
