**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of April 8, 2005, is made by TORONTO DOMINION (TEXAS) LLC., ("Torono Dominion"), pursuant to the termination of the Credit Agreement, by and among, Toronto Dominon and STADACONA INC., a Canada corporation (the "Grantor").

WITNESSETH

WHEREAS, pursuant to the General Security Agreement ("Security Agreement") by and among the Grantor and Toronto Dominion, dated February 25, 2004 and recorded with the U.S. Patent and Trademark Office on May 6, 2004, at Reel/Frame No. 2848/0282, the Grantor granted Toronto Dominion a security interest in its patents, patent applications, trade marks, trade names, copyrights, and other intellectual or industrial property, whether registered or not and whether under license or otherwise;

WHEREAS, Toronto Dominion acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement have been made;

WHEREAS, the Grantor has requested that Toronto Dominion release its security interest in its patents, patent applications, trade marks, trade names, copyrights, and other intellectual or industrial property, whether registered or not and whether under license or otherwise, as defined in the Security Agreement in connection with the termination of the Credit Agreement (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, Toronto Dominion hereby RELEASES, without recourse, all of its security interest in the trademark and trademark application listed on Schedule A attached hereto and incorporated herein by reference, and any other collateral described in the Security Agreement.

Toronto Dominion agrees to provide the Grantor with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.

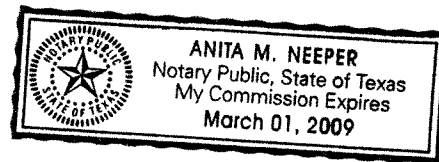
