**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks is granted and conveyed as of this 3rd day of May, 2005, by LaSalle Bank National Association (formerly, LaSalle National Bank), a national banking association, having an office at 135 S. LaSalle Street, Chicago, IL 60603 ("LaSalle") in favor of The GSI Group Inc. (formerly, Grain Systems, Inc.), a Delaware corporation, having an office at 1004 East Illinois Street, Assumption, IL 62510 ("GSI").

WHEREAS, pursuant to a certain Amended and Restated Trademark Security Agreement dated February 4, 1999 ("Security Agreement"), GSI granted LaSalle a security interest in, among other things, certain trademarks, including the trademark registrations and applications listed on the attached Schedule A ("Trademarks") and recorded such security interest with the United States Patent and Trademark Office on November 29, 1999 at Reel 1998, Frame 0575;

WHEREAS, GSI granted LaSalle such security interest to secure its Obligations to LaSalle under a certain Fourth Amended and Restated Loan and Security Agreement dated February 4, 1999, as amended and supplemented ("Loan Agreement");

WHEREAS, GSI has satisfied all of its Obligations to LaSalle under the Loan Agreement and is desirous of recording this instrument to confirm and evidence termination and release of the security interests of LaSalle in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacies of which the parties hereby acknowledge, LaSalle agrees as follows:

1. LaSalle, on behalf of itself, its successors and assigns, and as Agent for the Banks under the Loan Agreement, hereby terminates and releases all security interests in, to and under the Trademarks, including all renewals and extensions thereof, all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into or in connection therewith, and damages and payments for past, present or future infringements or dilution thereof, the right to sue for past, present and future infringement or dilution thereof, and all other rights corresponding thereto throughout the world, together with all goodwill of the business associated with and symbolized by the Trademarks and all such rights therein.

2. By this instrument, LaSalle hereby authorizes and requests the appropriate government officials, whose duty it is to record security interests, to record this release and termination of security interest against the Trademarks.
