**TRADEMARK ASSIGNMENT**


**WHEREAS**, Admanco, Inc., a Wisconsin corporation, with a principal place of business at 700 Stanton Street, Ripon, WI 54971 ("Assignor"), adopted, owned, and used the trademark **ADMANCO** ("the Mark") in connection with, but not limited to, the following goods: aprons, caps, bibs, fabric draw string bags, fabric barrel bags, tote bags, flight bags, cloth danger flags, towels, pot holders, and blankets; and

**WHEREAS**, Assignor owned a federal registration for the Mark on the Principal Register of the United States Patent and Trademark Office in connection with the goods identified therein, Trademark Registration No. 1,435,560 registered on April 7, 1987; and

**WHEREAS**, EBSCO Industries, Inc., a Delaware corporation, with a principal place of business at 5724 Highway 280 East, Birmingham, AL 35242 ("Assignee"), acquired the Mark, and the above-referenced registration in connection with that certain Asset Purchase Agreement dated January 21, 2005 between Michael S. Polsky, as Receiver for Admanco, Inc., and EBSCO Industries, Inc.;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all right, title and interest in and to the Mark, together with the goodwill symbolized by the Mark, and the registration thereof, *nunc pro tunc*, effective as of the 24<sup>th</sup> day of January, 2005.
