ASSIGNMENT OF TRADEMARK

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby irrevocably assigns, conveys, sells, grants and transfers and agrees to assign, convey, sell, grant and transfer to Assignee, his successors and assigns all of her respective rights, title and interest of every kind and character throughout the world, including moral rights, in and to the Application for Trademark and any other rights or interests Assignor may have therein, including, without limitation, all federal, state, foreign, statutory and common law and other rights; all domestic and foreign trademark applications and registrations therefor (and all extensions and renewals of such applications and registrations, and the right to apply for any of the foregoing); all goodwill associated therewith symbolized by the Application for Trademark; all rights to causes of action and remedies related thereto (including, without limitation, the right to sue for past, present or future infringement, misappropriation or violation of rights related to the foregoing); and any and all other rights and interests she have arising out of, in connection with or in relation to the Application for Trademark.
