as the same would have been held by Assignor had this assignment and sale not been made.

Assignor hereby agrees, without further consideration and without expense to Assignor, to sign all lawful papers and to perform all other lawful acts which Assignee may request of Assignor to make this Assignment fully effective, including, by way of example but not of limitation, the following: prompt execution of all United States and foreign trademark applications for said Mark, and all lawful documents as requested by the Assignee to further the prosecution of any of such trademark applications; cooperation to the best of Assignor's ability including, but not limited to, the execution of all lawful documents, the production of evidence in any actions or proceedings concerning the Mark, including, but not limited to, enforcement, registration, opposition, and infringement proceedings involving the Mark.

This assignment and agreement shall be binding upon Assignor's successors, assigns and legal representatives.

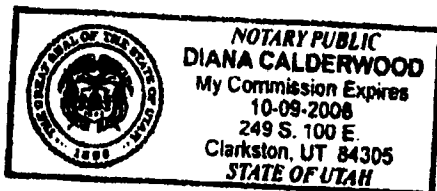
