## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement"), between Sonne Labs, Inc., a North Dakota corporation located at 896 – 22<sup>nd</sup> Avenue North, Wahpeton, North Dakota 58075 ("Assignor"), and Giant Snacks, LLC, a North Dakota limited liability company located at 896 – 22<sup>nd</sup> Avenue North, Wahpeton, North Dakota 58075 ("Company"), is executed on May 9, 2005.

### RECITALS

- A. Assignor owns and has a bona fide intent to use the following trademark (the "Mark") for which there is a pending Intent-to-Use application for federal registration:

- B. Assignor hereby assigns the Mark to Company pursuant to the Bill of Sale between Assignor and Company, dated October 29, 2003. Company is acquiring the business of the Assignor in connection with which Assignor has a bona fide intent to use the Mark for which there is a pending Intent-to-Use application for federal registration.

### AGREEMENT

In consideration of the above recitals and the promises set forth in this Agreement, the parties agree as follows:


