**RELEASE AND TERMINATION  
(Intellectual Property Security Agreement)**

RELEASE AND TERMINATION dated November 2, 2004 (this "Release and Termination") made by UBS AG, Zurich as security agent (the "Security Agent") for the Finance Parties (such term being used herein as it is defined in the Credit Agreement referred to below).

**PRELIMINARY STATEMENTS**

(1) Certain advances and financial accommodation have been made available pursuant to the Facilities Agreement dated as of April 4, 2001 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") between Kaba Corporation, UBS AG, Zurich, as Agent and as Security Agent and certain Lenders party thereto.

(2) A security interest in, among other property, certain intellectual property of the Grantors (as hereinafter defined) was granted pursuant to the Intellectual Property Security Agreement dated October 1, 2001 (the "IP Security Agreement") made by Kaba Corporation, Kaba Ilco Corp., Kaba High Security Locks Corporation, Ilco Unican Properties Inc., Kaba MAS Corporation and Kaba Benzing America Inc. (collectively, the "Grantors") in favor of the Security Agent.

(3) The Security Agent, on the instructions of the other Finance Parties, has agreed to terminate and release the security interests arising under the IP Security Agreement.

NOW, THEREFORE:

1. The Security Agent, for itself and the other Finance Parties, hereby (i) releases and terminates the assignments and security interests granted by the Grantors under the IP Security Agreement to the Security Agent and the other Finance Parties, and (ii) reassigns, transfers and sets over to each Grantor all right, title and interest in and to the Collateral (as defined in the IP Security Agreement) of such Grantor granted to the Security Agent and the other Finance Parties under the IP Security Agreement, including without limitation:

(i) the United States international, and foreign patents and patent applications set forth on Schedule A hereto together with all reissues, divisions, continuations, continuations-in-part, extensions and reexaminations thereof, and all rights therein provided by international treaties or conventions;

(ii) the United States and foreign trademark and service mark registrations and applications set forth in Schedule B hereto; and

(iii) the copyrights and United States and foreign copyright registrations and applications set forth in Schedule C hereto.

2. This Release and Termination shall be binding upon and inure to the benefit of the Security Agent, the other Finance Parties (including, but not limited to, the Lenders (as defined in the Credit Agreement) from time to time) and the Grantors and their respective successors and assigns.

3. This Release and Termination shall be governed by, and construed in accordance with, the laws of the State of New York.

**IN WITNESS WHEREOF**, the Security Agent has caused this Release and Termination to be duly executed and delivered by its officer thereunto duly authorized as of the date first written above.
