AGREEMENT TO SELL

THIS AGREEMENT is made by and between Sector 9, Inc. ("Sector 9") and Gull Wing Products, Inc. ("GullWing") in consideration of the following premises:

A. Gull Wing is the owner of certain intellectual property and trademarks ("the Property"), copies of which are attached hereto and marked in the collective as "Exhibit "A".

B. Sector 9 is willing to pay the sum of \$ 20,000.00 in exchange for a transfer of the Property.


NOW, THEREFORE, in consideration of the premises the receipt and sufficiency of which is hereby acknowledged by the parties hereto, the parties agree as follows:

1. As consideration, Sector 9 shall pay to GullWing, or its assignee, the price or sum of \$20,000.00 in lawful money of the United States of America. Gull Wing to allow Sector 9 180 days from the date of this agreement to pay in full the sum of \$20,000.00.


2. Gull Wing shall, and hereby does, immediately transfer all of its right, title and interest in the Property.
