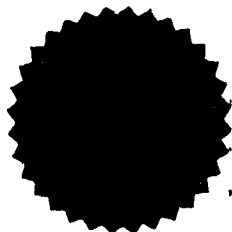

SECOND: The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations.

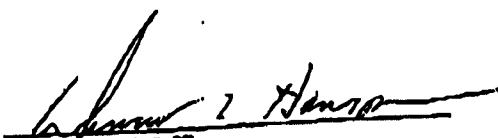
THIRD: The name of the surviving corporation is Conn-Selmer, Inc., a Delaware corporation.
