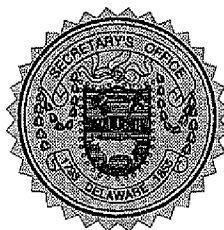

**FIRST:** That this Corporation was originally incorporated pursuant to the General Corporation Law on December 14, 2000, under the name of SkyPilot Network, Inc.

**SECOND:** That pursuant to Section 141 and 242 of the General Corporation Law of the State of Delaware, the Board of Directors duly adopted resolutions proposing to amend the Amended and Restated Certificate of Incorporation of this Corporation, declaring said amendment to be advisable and in the best interests of this Corporation and its stockholders, which resolution setting forth the proposed amendment is as follows:

Article I shall be amended and restated to read in its entirety as follows:

"The name of this company is SKYPILOT NETWORKS, INC. (the "Company")."
