TRADEMARK ASSIGNMENT - UNITED STATES

Assignor shall promptly cooperate with and take such further actions and execute all such further assignments, instruments and documents as Assignee requests which are necessary or desirable in order to fully vest legal and beneficial ownership of the trademarks listed in the Schedule hereto in Assignee.

This Assignment shall be governed by the internal laws of the State of Illinois without regard to principles of conflicts of law. This Assignment may be executed in

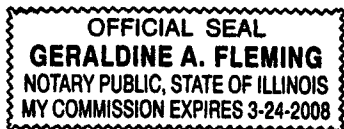



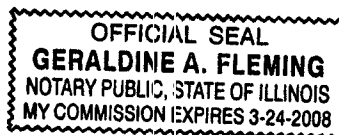
