TRADEMARK ASSIGNMENT

Trademark Assignment made as of this 1st day of September, 2004.

WHEREAS, LEISURE PUBLICATIONS, INC. ("LEISURE") has acquired, used, and is using the trademark "Mobility Management" in connection with the publication of a magazine;

WHEREAS, LEISURE is desirous of transferring all of its trademark interest in and to "Mobility Management" together with the trademarks set forth on Schedule "A" hereto (the "Trademarks") to STEVENS COMMUNICATIONS, INC., a Texas corporation ("STEVENS"), with its principal place of business at 5151 Belt Line Road, Suite 1010, Dallas, Texas 75240, and STEVENS is desirous of acquiring such interest;

NOW, THEREFORE, for good and valuable consideration expressed in that certain Asset Purchase Agreement dated as of Aug 3, 2004, between STEVENS and LEISURE (the "Agreement"), receipt of such consideration being hereby acknowledged by LEISURE, LEISURE does hereby assign and transfer to STEVENS, without restriction, all of LEISURE's right, title, and interest, worldwide, in and to the Trademarks together with the good will of the business symbolized by the Trademarks, registrations thereof, and applications for registration thereof. Without limitation of the generality of the interest conveyed, said conveyance includes (i) all of LEISURE's right, title, and interest (both statutory and common law) in and to the Trademarks and any and all registrations and applications for registration thereof in the United States (including United States Trademark Registration No. 2710988 for the mark: Mobility Management) and throughout the world; and (ii) all trademark enforcement rights and remedies which LEISURE may now have with respect to the Trademarks including LEISURE's standing to assert civil, criminal, and administrative remedies of all kinds and LEISURE's right to damages for past infringement thereof.

PROVIDED, that this Assignment shall be without recourse or warranty against LEISURE except that LEISURE warrants: (1) that it is transferring all rights its has in the Trademarks to STEVENS; (2) that it is the owner of all rights being assigned; (3) that it has not assigned or transferred such rights to any other persons whatsoever; (4) that it will not contest the use of such rights by STEVENS; and (5) that the representations made by LEISURE in the Asset Purchase Agreement regarding the Trademarks (subject to any limitations expressly made thereon) are true and correct. ALL OTHER WARRANTIES REGARDING THE TRADEMARKS ARE EXPRESSLY DISCLAIMED.

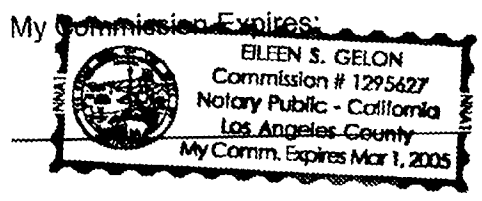
