10. CRL, Inc.'s products are sophisticated commercial purchasers of gunsmith supplies, and original equipment manufacturers of rifles, pistols and shotguns. The products sold by CRL, Inc., are purchased by commercial specifications.

13. CRL, Inc., agrees that if the sale of the cutlery and clothing business to Marble's Cutlery LLC is completed, CRL, Inc., will not use the mark MARBLE'S for the sale of
- A. hunting knives, fish knives, safety pocket axes and camp axes; and
  - B. caps, t-shirts, sweatshirts, coats and jackets.
14. In consideration of the mutual promises contained herein, CRL, Inc., and Marble's Cutlery LLC, agree as follows:
- A. Marble's Cutlery LLC agrees to restrict its use and registration of the trademark "MARBLE'S" and any mark similar thereto, to:
    - 1. hunting knives, fish knives, safety pocket axes and camp axes; and
    - 2. caps, t-shirts, sweatshirts, coats and jackets.
15. Marble's Cutlery LLC agrees that if the sale of the cutlery and clothing business by CRL, Inc., is completed, Marble's Cutlery LLC will not use the mark:
- "MARBLE'S" U.S. Registration No. 2,086,685, in International Class 009, for directional compasses, and in International Class 013 for non-optical rifle and shotgun sights, rifle cleaning rods, gun cleaning kits comprised of gun cleaning brushes, patches, cloths, non-freeze oil, gun oil and solvent, ventilated sighting ribs for gun barrels.
16. CRL, Inc., and Marble's Cutlery LLC agree that neither will oppose either's use of the marks within the restrictions described, and neither will seek to cancel any registration issuing from said application, as long as such application and registration are consistent with this Agreement.
17. CRL, Inc., and Marble's Cutlery LLC further agree that in the event any registration of the mark "MARBLE'S" becomes an obstacle to either's renewing the marks, both will provide and furnish letters of consent as are necessary for CRL, Inc., and Marbles Cutlery LLC, to obtain registration of the mark "MARBLE'S" for their respective goods consistent with this Agreement.




