TRADE MARK ASSIGNMENT

This Assignment is made on 11 March 2005 between

- (1) Scottish & Courage Limited, whose registered office is at 33 Ellersley Road, Edinburgh, EH12 6HX (the "Assignor"); and
- (2) Scottish & Newcastle plc, whose registered office is at 33 Ellersly Road, Edinburgh, EH12 6HX (the "Assignee").

Whereas:

- (A) The Assignor is the owner of the trade mark registrations set out in Schedule 1 (the "Trade Marks").
- (B) The Assignor has agreed to assign all its right, title and interest in and to the Trade Marks to the Assignee for the consideration mentioned below.

It is agreed as follows:

1 Assignment

In consideration of the sum of £1, receipt of which is acknowledged by the Assignor, the Assignor assigns to the Assignee all its right, title and interest in the Trade Marks including any common law rights and all the goodwill attaching to the Trade Marks and all rights of action arising or accrued relating to the Trade Marks including, without limitation, the right to take proceedings (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks) and to seek and recover damages and all other remedies for all past infringements.

2 Further Assurance

At any time after the date of this Assignment, at the request of the Assignee, the Assignor shall and shall use its best endeavours to procure that any necessary third party shall execute such documents and do such acts and things as the Assignee may reasonably require for the purpose of giving to the Assignee the full benefit of all the provisions of this Assignment.

3 Law and Jurisdiction

- 3.1 This Assignment shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the courts of England shall have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this Assignment.
