DECLARATION OF JAMES R. BILLINGS


I, James R. Billings, declare as follows:

1. I make this declaration in support of an assignment of the above listed trademark registrations made by Stanford Holdings, Ltd., a New York corporation, to Turf Merchants, Inc., an Oregon corporation. A executed copy of the Trademark Assignment from Stanford Holdings, Ltd. to Turf Merchants, Inc. for the above listed trademark registrations is provided with this declaration.
2. I am the President of Stanford Holdings, Ltd., a New York corporation, and I make this declaration on my own personal information and belief;
3. New Stanford, Inc., a Delaware corporation, acquired title to the above mentioned trademark registrations through a September 22, 1986 merger with a number of corporations. The merger was recorded with the USPTO Assignment Division at reel/frame number 0686/0875. New Stanford, Inc. was the surviving company.
4. Stanford Holdings, Ltd., a Delaware Corporation, acquired title to the trademark registrations listed above through a merger of a number of corporations which included Stanford, Inc., a Delaware corporation. Stanford Holdings, Ltd., a Delaware corporation, was the surviving party;
5. Stanford Holdings, Ltd., a New York corporation, acquired title to the trademark registrations listed above through a February 10, 1994 merger with Stanford Holdings, Ltd., a Delaware Corporation on February 10, 1994. Stanford Holdings, Ltd., a New York corporation, was the surviving party.

6. Stanford Holdings, Ltd., a New York corporation, assigned the above mentioned trademark registrations to Turf Merchants, Inc., an Oregon Corporation. The assignment was effective March 15, 1995.


