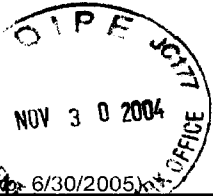

## TERMINATION OF SECURITY INTERESTS IN TRADEMARKS AND PATENTS

This Termination of Security Interests in Trademarks and Patents (the "**Termination**") is made and entered into to be effective as of November 4, 2004 (the "**Effective Date**"), by and between Bank One, N.A. ### Background:

1. On or about January 21, 2002, Bank One and Perio entered a Trademark Assignment of Security and a Patent Assignment of Security (collectively, the "**Security Assignments**"). 
### Termination
