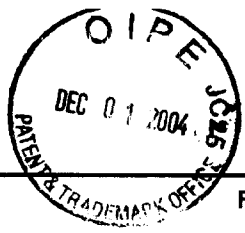



CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS Bombardier Recreational Products Inc., a corporation incorporated under the laws of Canada having an office at 1601 Parent Street, St. Bruno, Quebec, J6V 6P1 (the “**Assignor**”), is the registered owner of certain trade-marks and trade-mark applications (collectively, the “**Trade-marks**”) listed in the Schedules hereto;

WHEREAS pursuant to an Asset Purchase Agreement (the “**Asset Purchase Agreement**”) dated July 27, 2004 between the Assignor and Camoplast Inc. (“**Camoplast**”), the Assignor has agreed to assign, sell or otherwise transfer to Camoplast or one or more assignee thereof or parties designated thereby certain property and assets, as more particularly described in the Asset Purchase Agreement;

WHEREAS on August 27, 2004, Camoplast designated Camoplast Industrial Inc., a corporation incorporated under the laws of Canada having its registered office at 2144 King Street West, Suite 110, Sherbrooke, Quebec, J1J 2E8 (the “**Assignee**”), to purchase certain assets from the Assignor and assigned to the Assignee part of its rights and obligations under the Asset Purchase Agreement, including all of its rights and obligations with respect to the Trade-marks;

WHEREAS the Assignor hereby wishes to confirm that it has assigned to the Assignee all its right, title and interest in and to the Trade-marks.

In consideration of the foregoing and the mutual agreements contained in the Asset Purchase Agreement (the receipt and adequacy of which have been acknowledged), the parties agree as follows:

**ARTICLE 1
ASSIGNMENT**

The Assignor and the Assignee hereby confirm that all the Assignor's rights, title and interest in and to the Trade-marks have been assigned, sold or otherwise transferred to the Assignee.

**ARTICLE 2
REGISTRATION**

The Assignor consents to an application to the relevant governmental authority of the jurisdictions where the Trade-marks are registered for recognition of the aforementioned assignment of the Trade-marks.

**ARTICLE 3
COUNTERPARTS**

This Confirmatory Assignment may be executed in counterparts, each of which shall be an original and all of which taken together shall constitute one and the same instrument.
