WITNESSETH

WHEREAS, the Collateral Agent, Equinix, Inc. ("Equinix") and certain subsidiaries of Equinix (collectively, the "Additional Grantors") entered into a Master Pledge and Security Agreement dated as of December 31, 2002 (the "Pledge Agreement"); and

WHEREAS, pursuant to the Pledge Agreement, Equinix granted to the Collateral Agent a security interest in certain trademarks owned by Equinix, including the trademarks listed in the schedule attached hereto as Schedule A (the "Trademarks"), which security interest was recorded on September 29, 2003 in the Assignment Branch of the U.S. Patent & Trademark Office ("USPTO") at Reel 2833, Frame 0656; and

NOW, THEREFORE, the Collateral Agent hereby agrees as follows:

Effective September 28 OCT 2004, 2004, the Collateral Agent hereby releases, waives, resigns and disclaims any and all security interests in any of the Trademarks.


