RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS

Reference is hereby made to that certain Trademark Security Agreement, dated as of April 13, 2005, executed by Farmland Dairies LLC, a Delaware limited liability corporation ("**Company**"), in favor of LaSalle Business Credit, LLC, as Agent ("**Lender**"), which was recorded in the United States Patent and Trademark Office on _____, at Reel _____, Frame _____ (the "**Security Agreement**") and pursuant to which the Company assigned and granted to Lender, a security interest in and to all of Company's right, title and interest in and to certain trademarks, including those trademarks specifically listed on Exhibit A attached hereto (the "**Marks**") and the goodwill associated therewith; and

WHEREAS, Lender wishes to release, retransfer and reassign to Company without reservation or condition, and with representation or warranty that it has not pledged, transferred, assigned, mortgaged, sold, assigned or otherwise encumbered the rights titles and interests in said Marks, Lender's entire right, title and interest in and to the Marks and the goodwill associated therewith;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby

(i) releases, retransfers and reassigns to Company, without reservation or condition, and with representation and warranty that it has not pledged, transferred, assigned, mortgaged, sold, assigned or otherwise encumbered the rights, titles and interests in said Marks, all of Lender's entire right, title and interest in and to the Marks and all trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, other business identifiers, prints and labels on which any of the foregoing have appeared or appear, all registrations and recordings thereof, and all applications (other than "intent to use" applications until a verified statement of use is filed with respect to such applications) in connection therewith, all renewals thereof, and all income, royalties, damages and payments now or hereafter due and/or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for past, present and future infringements of any of the foregoing and the right to sue for past, present and future infringements of any of the foregoing; all rights corresponding to any of the foregoing throughout the world and the goodwill associated therewith; and

(ii) agrees to reasonably assist the Company, at no additional cost or fees to Lender, in releasing, recording, applying for, obtaining release of its security interest in and to said Marks with appropriate government authorities, including but not limited to the United States Patent and Trademark Office and any other local and state government authorities.
