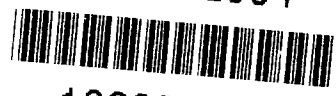



Assignor agrees that when requested by Assignee it will, at the sole cost of Assignee, execute all documents necessary or desirable to properly vest full right, title and interest in and to the Marks throughout the world in the name of Assignee or which, in the sole judgment of Assignee, may be necessary to obtain, maintain, issue or enforce Marks.

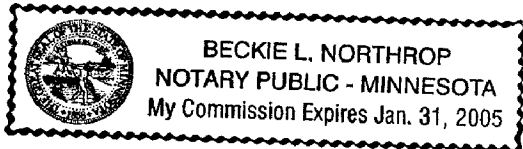
