

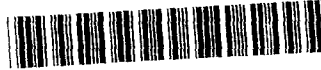

NOW THEREFORE, in consideration of payment of the sum of Ten Dollars


