TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE is made as of May 6, 2005 (the "Effective Date") among Survey Sampling International, LLC, a Delaware limited liability company (the "Grantor"), and The Bank of New York, as administrative agent (in such capacity, the "Administrative Agent"), for the benefit of the Secured Parties (as defined in the Trademark Security Agreement, as hereinafter defined).

WHEREAS, pursuant to the terms and conditions of (i) that certain Grant of Security Interest (Trademarks), dated as of January 31, 2003, among the Grantor and the Administrative Agent (the "Trademark Security Agreement") a security interest was granted by the Grantor to the Administrative Agent in certain Pledged Trademarks (as hereinafter defined);

WHEREAS, the Trademark Security Agreement relating to the Pledged Trademarks was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on February 6, 2003 at Reel 2665, Frame 0477;

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Pledged Trademarks;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Pledged Trademarks pursuant to the Trademark Security Agreement the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Pledged Trademarks: The term "Pledged Trademarks," as used herein, shall mean all of the Grantor's right, title and interest in and to all of the Grantor's United States trademarks, service marks, trade names, trade dress or other indicia of trade origin, trademark and service mark registrations, and applications for trademark or service mark registrations (except for "intent to use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, unless and until an Amendment to Allege Use or a Statement of Use under Sections 1(c) and 1(d) of said Act has been filed), and any renewals thereof, including, without limitation, each registration and application identified in Schedule I attached hereto and made a part hereof, and including without limitation (a) the right to sue or otherwise recover for any past, present and future infringements and misappropriations thereof, (b) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past or future infringements thereof) and (c) all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress or other indicia of trade origin.

2. Release of Security Interest: The Administrative Agent hereby terminates, releases and discharges its security interest in the Pledged Trademarks, and any right, title or

interest of the Administrative Agent in such Pledged Trademarks shall hereby cease and become void.

3. Further Assurances: The Administrative Agent shall execute and deliver to the Grantor all further releases and other documents (including without limitation Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of such Security Interest.
