RELEASE OF SECURITY INTEREST

WHEREAS, Huddle House, Inc., a Georgia corporation (the "Company"), granted a security interest in the trademark registrations listed on the schedule attached to this Release of Security Interest (the "Schedule") to BNP PARIBAS (formerly known as Banque Paribas), as collateral agent (the "Secured Party"), pursuant to a Security Agreement dated June 30, 1994 (the "Security Agreement");

The Secured Party hereby releases any and all security interests granted pursuant to the Security Agreement to the Secured Party by the Company in each trademark registration listed on the Schedule together with any reissues, continuations or extensions thereof, and assigns to the Company all right, title and interest it may have in each trademark registration listed on the Schedule, and the goodwill symbolized by the registered marks.
2. The Secured Party hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office to note and record the existence of the release hereby created.
