**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of April 18, 2005 (this "Release"), is made by Heller Financial, Inc., as collateral agent for certain lenders (in such capacity, the "Collateral Agent") in favor of Protection One Alarm Monitoring, Inc., a Delaware corporation ("Protection One"), as follows:

W I T N E S S E T H

WHEREAS, pursuant to that certain Grant of Security Interest, dated November 3, 1993 (the "Grant of Security Interest"), by and between Collateral Agent and Protection One, and recorded with The United States Patent and Trademark Office on December 13, 1993 at Reel/Frame No. 1077/0378, Protection One granted the Collateral Agent a security interest in and to all of Protection One's right, title and interest in and to all of the trademarks owned by Protection One, and all applications and registrations therefor, together with the goodwill associated therewith (the "Collateral");

WHEREAS, Protection One has satisfied all of its obligations as set forth in the Security Agreement (as defined in the Grant of Security Interest); and

WHEREAS, Protection One has requested that the Collateral Agent release its security interest in and to the Collateral granted by the Grant of Security Interest and to terminate the Grant of Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent, without recourse, representation or warranty and at Protection One's sole cost and expense, hereby TERMINATES, CANCELS and RELEASES any and all security interests it has in the Collateral, including, but not limited to, each of the trademark registrations set forth in Schedule A, attached hereto and incorporated herein by reference, together with the goodwill of the business symbolized by said trademarks.

For the avoidance of doubt, nothing in this Release shall be deemed a representation and warranty with respect to the Collateral, or Protection One's or the Collateral Agent's right, title or interest therein or thereto.
