WHEREAS, THE Assignor has agreed to assign the Trademarks to the Assignee, and the Assignee has agreed to accept said assignment.

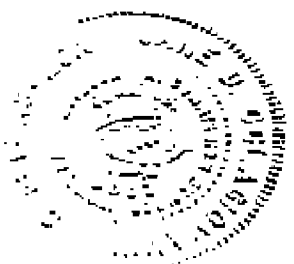

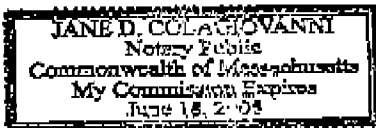
