## CONFIRMATION OF TRADEMARK ASSIGNMENT



**NOW, THEREFORE**, the undersigned hereby confirm that effective November 29, 1999, for good and valuable consideration, Assignor assigned, transferred, granted, and sold to Assignee all right, title, and interest in and to the Mark and the Registration, throughout the world, together with the goodwill of Assignor's business in connection with which the Mark is used, and the full right to sue for past, present, and/or future infringement of the Mark and the Registration, all of such rights to be held and enjoyed by the Assignee, its successors and assigns, as fully as the same would have been held and enjoyed by the Assignor had the assignment not been made.

**IN WITNESS WHEREOF**, Assignor and Assignee have caused this instrument to be signed by duly authorized corporate officers.



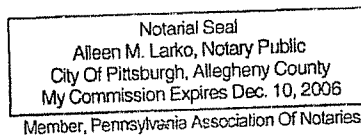


