**RELEASE**

THIS RELEASE is dated effective as of May 31, 2001 by Foothill Capital Corporation, a California corporation having an office at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404, as Agent ("Agent") for various lenders under certain loan agreements (the "Lenders").

WHEREAS, Agent, on behalf of the Lenders, has entered into certain Trademark Security Agreements with Nevada Bob's Pro Shop, Inc., a Nevada corporation, GDH International, Inc., a Texas corporation, and March Acquisition, Inc., a Texas corporation (collectively, the "Borrowers") whereby the Agent, for the benefit of the Lenders, has security interests in and to certain "Collateral" (as defined in the Trademark Security Agreements);

WHEREAS, the Trademark Security Agreements were recorded in the United States Patent and Trademark Office ("USPTO") at Reel No. 1973, Frame No. 0684, Reel No. 1975, Frame No. 0599, Reel No.2028, Frame No. 0552, and Reel No. 2142, Frame No. 0899.

WHEREAS, Agent, on behalf of the Lenders, desires to fully release the aforesaid security interests in the Released Collateral, as defined below.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent, for itself and on behalf of each of the Lenders, hereby reassigns, grants, and conveys to the Borrowers, without recourse and without any representation of any kind, all of Agent's and Lenders' right, title, and interest, if any, in and to the Collateral listed on Schedule A attached hereto, (collectively, the "Released Collateral").
2. Agent, for itself and on behalf of each of the Lenders, hereby confirms that it has not assigned or transferred its interests in the Trademark Security Agreements or in the Released Collateral.
3. Agent, for itself and on behalf of each of the Lenders, hereby releases all of Agent's and Lenders' security interests in and liens on the Released Collateral.
4. Agent, for itself and on behalf of each of the Lenders, hereby directs and authorizes the law firms of Jacobson Holman, PLLC, Freeborn & Peters and/or Macleod Dixon LLP to file this Release for recordation in the USPTO and any other appropriate Offices.
5. Agent makes no representation or warranty of any kind regarding (i) the existence of any Released Collateral, (ii) the nature of any Borrower's interest in any Released Collateral, or (iii) the attachment, perfection or similar creation of a security interest in and to the Released Collateral.
