**DECLARATION IN SUPPORT OF CORRECTING RECORDED CHAIN OF TITLE**

I Herbert I. Peck declare as follows:

1. I am Associate General Counsel for Anixter-Real Estate, Inc., owner of the mark ANIXTER LEVELS, Registration No. 2,327,814 (the "Mark"). I am also Associate General Counsel for Anixter Inc., prior owner of the Mark.

2. I make this declaration in accordance with TMEP 503.06(c) and on the basis of my personal knowledge and investigation of the matters described. As described further below, the following documents erroneously filed by Arris International, Inc., record a purported grant and release of a security interest in the Mark: Reel 2348/Frame 0573; Reel 2796/Frame 0384.

**Summary of True Chain of Title for ANIXTER LEVELS**

3. Registration No. 2,327,814, for the mark ANIXTER LEVELS, was issued on March 14, 2000, to Anixter Inc.

4. On July 31, 2000, Anixter, Inc. assigned the Mark to Anixter-Real Estate, Inc. This assignment was recorded on August 2, 2000.

5. On July 31, 2000, Anixter-Real Estate, Inc. granted a license of the Mark to Anixter, Inc. This license was recorded on September 7, 2000.

6. Since July 31, 2000, Anixter-Real Estate, has been, and continues to be the owner of the Mark.

**Documents Mistakenly Recorded for ANIXTER LEVELS**

7. On August 10, 2001, a company named Arris International, Inc. recorded a purported security interest in the registration to The CIT Group Business/Credit, Inc. at Reel 2348/Frame 0573.

8. On February 19, 2004, CIT recorded a purported release of the security interest at Reel 2796/Frame 0384.


9. Arris International has never owned or had any interest in the Mark. Arris has never had the authority to grant or record any security interest in the Mark as it purported to do. The recordation of the alleged security interest grant and release should be considered null and void. The recordation does not affect the true chain of title for the Mark described above in Paragraphs 3 to 6.

10. I have spoken with Lawrence A. Margolis, Executive Vice President of Arris International, Inc. concerning the recordation of the purported security interest and release. Through Mr. Margolis, Arris has acknowledged that the recordation it made was mistaken and does not affect the true chain of title for the Mark. A declaration from Mr. Margolis confirming this understanding accompanies this declaration.

**DECLARATION IN SUPPORT OF CORRECTING RECORDED CHAIN OF TITLE**

I Lawrence A. Margolis, declare as follows:

1. I am Executive Vice President of Arris International, Inc., a Delaware corporation. Arris is located at 3871 Lakefield Drive, Suwanee, GA 30024. I have held this position for 13 years. I make this declaration based on personal knowledge.

2. I provide this declaration in support of Anixter-Real Estate, Inc.'s request to correct the record of the chain of title for the mark ANIXTER LEVELS, U.S. Reg. No. 2,327,814 ("the "Mark").


3. On August 10, 2001, Arris recorded a purported grant of a security interest in the Mark from The CIT Group Business/Credit, Inc. to Arris. The purported grant was recorded at Reel 2348/Frame 0573.

4. On February 19, 2004, Arris recorded a purported release of a security interest in the Mark from The CIT Group Business/Credit, Inc. to Arris. The purported release was recorded at Reel 2796/Frame 0384.

5. The purported grant, release and recordation were made by Arris in error. Arris does not, and never has, owned or had any interest in the Mark. Arris has never had the authority to grant or record any security interest in the Mark as it purported to do. The recordation of the alleged security interest should be considered null and void. The recordation does not affect the true chain of title for the Mark.
