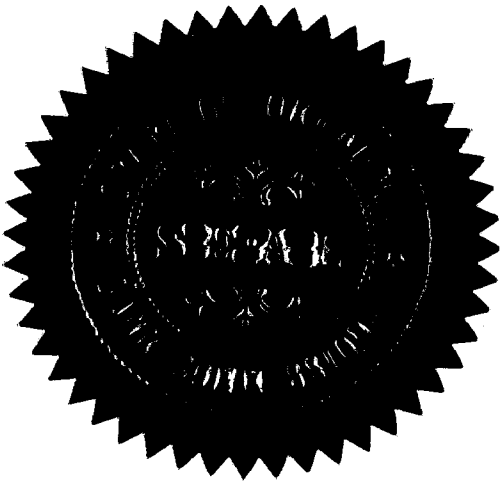

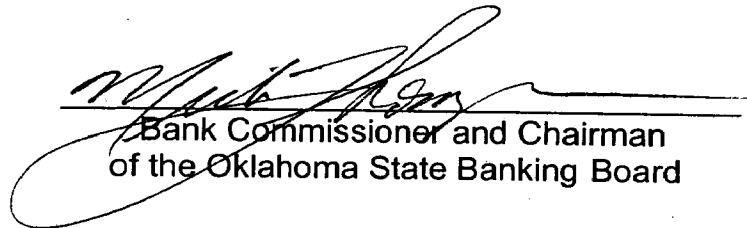
CERTIFICATE OF CONVERSION

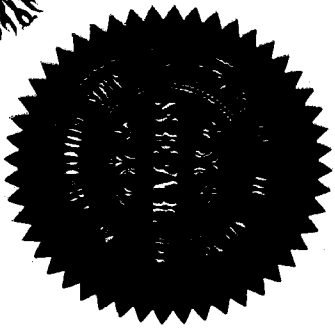
