RELEASE OF SECURITY INTEREST
(Trademarks)

This RELEASE OF SECURITY INTEREST (Trademarks) (this "Release") is made and effective as of the 22 day of March, 2005 (the "Effective Date") and is granted by INTERPEL CORP., as Agent ("Interpel"), in favor of AUTOMOTIVE CALIPER EXCHANGE INCORPORATED (the "Releasee").

WHEREAS, the Releasee executed that certain Trademark Security Agreement, dated as of July 16, 2001 (the "Assignment"), in favor of Interpel, pursuant to which the Releasee granted to Interpel a continuing security interest in all of the Releasee's right, title and interest in, to and under the trademarks and trademark registrations listed on the annexed Schedule A (the "Trademark Collateral"), to secure the payment, performance and observance of the obligations referred to therein;


WHEREAS, the Assignment was recorded at the United States Patent and Trademark Office at Reel 2354, Frame 744 on August 10, 2001; and

WHEREAS, the obligations secured by the Trademark Collateral have been discharged.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Interpel, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Trademark Collateral, and Interpel reassigns any and all such right, title and interest that it may have in the Trademark Collateral to the Releasee, free and clear of any claims by Interpel, together with all causes of action for past infringement. Upon this reassignment, all right, title and interest in the Trademark Collateral shall be vested in the Releasee as fully as if the Assignment had not been made.

IN WITNESS WHEREOF, Interpel has caused this Release to be duly executed by its officer thereunto duly authorized as of the Effective Date.
