**FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT**

FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT dated as of May 26, 2005 (this "Amendment") by UNIVERSAL HOSPITAL SERVICES, INC., a Delaware corporation ("Grantor"), in favor of GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, in its capacity as Agent for Lenders.

**WITNESSETH:**

WHEREAS, Grantor and Agent are parties to that certain Trademark Security Agreement dated as of October 17, 2003 (as amended, restated, modified or supplemented from time to time, the "Trademark Security Agreement"), entered into pursuant to that certain Security Agreement dated as of October 17, 2003 (as amended, restated, modified or supplemented from time to time, the "Security Agreement") between Grantor and Agent;

WHEREAS, each of the Trademark Security Agreement and the Security Agreement were entered into in connection with that certain Credit Agreement dated October 17, 2003 among Agent, Lenders and Grantor, which is being amended and restated as of the date hereof (the "Credit Agreement"); and

WHEREAS, pursuant to the Security Agreement, Grantor is required to execute and deliver to Agent, for itself and the ratable benefit of Lenders, this Amendment;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. DEFINED TERMS. All capitalized terms used by not otherwise defined herein have the meanings given to them in Annex A thereto to the Credit Agreement.

2. AMENDMENT TO THE TRADEMARK SECURITY AGREEMENT. Schedule I to the Trademark Security Agreement shall be amended and restated by deleting the information set forth on such Schedule and replacing such information with the information set forth on Exhibit A hereto.
