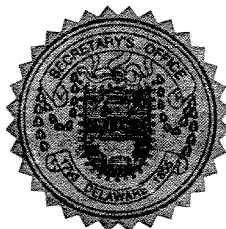

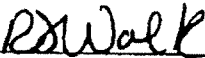
"FIRST: That the name of the Company is **O-N Minerals (James River) Company.**"
