Assignor further agrees to transfer to Assignee the original registration and/or application filing certificates for the U.S. Trademark registrations and applications listed above, as well as any original certificate of any other federal or state registration or recordal of said Trademark Rights together with any files pertaining to said Trademark Rights now in its possession or under its control.

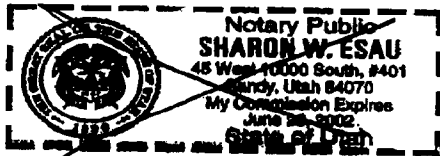

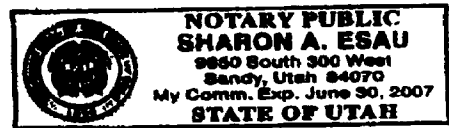
