NUNC PRO TUNC ASSIGNMENT OF U.S. TRADEMARK

WHEREAS, Franz Koch ("Assignor"), a citizen of Austria, having a principal place of business at Elisabethstr. 5, A-6020 Innsbruck, Austria, is the owner of the "KOCH" trademark and the registration thereof with the United States Patent and Trademark Office (reg. #1,738,085) (collectively, together with the application for registration thereof, all rights of priority therein in any country as may now or thereafter be granted to him by law, treaty or other international convention, and all rights, interests, claims and demands recoverable in law or equity that Franz Koch has or may have in profits and damages for past, present and future infringements of the "KOCH" trademark and the registration thereof with the United States Patent and Trademark Office, including without limitation the right to compromise, sue for and collect such profits and damages being hereinafter referred to as the "Mark"); and

WHEREAS, KOCH Holding Corp. ("Assignee"), a British Virgin Islands corporation, having its principal office at c/o Dr. Alfred Steinbrugger, Meierhofstr. 2, FL-9490 Vaduz, Liechtenstein, is desirous of acquiring the Mark for use in the United States: (i) as used in the Acquired Business (defined below) as of the date of execution of this Assignment, and (ii) in connection with audio and visual publishing and recordings of any kind, in any media (whether now known or later developed), and regardless of the nature of the content, and format and distribution channel (in each case present or future) (clauses (i) and (ii) collectively, the "Field of Use").

NOW, THEREFORE, in consideration of the sum of one (1) euro and other good and valuable consideration, receipt of which is hereby acknowledged, Assignor and Assignee agree as follows:

Assignor does hereby sell, transfer and assign unto Assignee all of his right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, for use in the Field of Use, *nunc pro tunc*, effective as of April 26, 2002.

This Assignment constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all other prior agreements and understandings, both written and verbal, between the parties or any of them with respect to the subject matter hereof.


