

**RELEASE AGREEMENT**


WACHOVIA BANK, NATIONAL ASSOCIATION, successor by merger to SOUTHTRUST BANK, an Alabama corporation ("Southtrust"), as Lender under the Trademark Security Agreement dated as of March 7, 2003 (the "Security Agreement") to which CANGEN HOLDINGS, LLC ("Cangen") and Southtrust are party, hereby unconditionally and irrevocably terminates, releases and discharges any and all of its right, title and interest in and to any and all of Cangen's right, title and interest in and to the Trademark Collateral (as defined in the Security Agreement), including, without limitation, the following: (a) all trademarks to which Cangen is a party, including, without limitation, the registered trademarks CEC, CVC, GENCA, AND TRI-DIE (Registration Numbers 1,728,353, 2,389,754, 1,293,932, and 1,210,277, respectively) (collectively, the "Trademarks"), (b) all reissues, continuations, or extensions of the Trademarks, (c) all goodwill of the business connected with the use of, and symbolized by each of the Trademarks, and (d) all products and proceeds of the Trademarks, including, without limitation, any claim by Cangen against third parties for past, present, or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.

Southtrust hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.
