SERVICE MARK ASSIGNMENT

WHEREAS, Circuit City Stores West Coast, Inc., a corporation duly organized and existing under the laws of the State of California and having offices at 9250 Sheridan Boulevard, Westminster, Colorado, United States of America, hereinafter referred to as "ASSIGNOR," has adopted and used, through its licensee, and is the owner of the service mark set forth on Schedule A hereto in connection with the services described therein (the "Mark"), together with the goodwill of the business in connection with which the Mark has been used (the "Goodwill") and the United States Trademark Registration for the Mark set forth on Schedule A (the "Registration"); and

WHEREAS, Patapsco Designs, Inc., a corporation duly organized and existing under the laws of the State of Maryland and having its principal office at 5350 Partners Court, Frederick, Maryland 21703, United States of America, hereinafter referred to as "ASSIGNEE," is desirous of acquiring the Mark, together with the Goodwill and the Registration;

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR has agreed to sell and has sold, assigned, transferred and set over, and by these presents does sell, assign, transfer and set over unto ASSIGNEE and its successors and assigns ASSIGNOR's entire right, title and interest in and to the Mark, the Goodwill, and the Registration, including the right to sue for past infringements, to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use and benefit of its subsidiaries, successors, assigns and legal representatives, for the full extent of the life of the Mark and the term of the Registration, to be used as fully and entirely as such rights would have been held and enjoyed by ASSIGNOR had this Assignment and sale not been made.

ASSIGNOR covenants that ASSIGNOR is the owner of the Mark and the holder of record title to the Registration, that ASSIGNOR has full power to make this Assignment and that ASSIGNOR agrees to execute such further assignments and related documents with respect to the Mark, the Goodwill, and the Registration as ASSIGNEE shall reasonably request.
