Background

Agreed terms

1. Assignment of Trade Mark

1.1 Assignment

With effect from the date of this Deed :

- (a) Assignor hereby assigns to Assignee all Assignor's entire right, title and interest in and to the Trade Mark including all Assignor's rights to institute and maintain proceedings for trade mark infringement, passing off, or under fair trading legislation, against any person who before, on or after the date of this Deed, used the Trade Mark or any substantially identical or deceptively similar trade mark, without Assignor's licence; and
- (b) Assignee accepts the assignment.

1.2 Consideration

Assignee hereby agrees to pay Assignor the sum of AUD 7,000 for the assignment of the Trade Mark.

2. Miscellaneous

- (a) This Deed and the transactions contemplated by it are governed by the law in force in Victoria, Australia.
- (b) This Deed may consist of a number of counterparts. These counterparts constitute one instrument.


