ASSIGNMENT OF I.B. DIFFUSION TRADEMARK

AGREEMENT made as of the 1st day of November, 2004 by and between I.B. Diffusion L.P., I.B.D. Acquisition, Inc., and Ronald Schmidt, all with offices at 5 Briar Lane , Glencoe, IL (hereinafter collectively known as "Assignors") and Regent International Corporation, with offices at 1411 Broadway, New York, NY ("Assignee" or "Regent").

WHEREAS, the parties to this agreement and assignment are also parties to a License Agreement dated April 24, 2000; and

WHEREAS, paragraph 6 of the License Agreement provides that Assignors will transfer ownership of the Licensed Marks and registrations to Regent International Corp. (the Licensee in that agreement) once Regent has paid Assignors a total of \$510,000 of sales royalty; and

WHEREAS, I.B. Diffusion L.P. has assigned to Ronald Schmidt all its right, title and interest to the I.B. Diffusion trademark in Canada; and

WHEREAS, Regent has paid Assignors a total of \$510,000 in sales royalty for the Licensed Marks.


NOW, THEREFORE, the parties hereto agree as follows:

Assignors hereby sell, transfer and assign to Regent International Corporation all its right, title and interest in the "I.B. Diffusion" trademark bearing Registration Number 1569721 in the United States Patent and Trademark Office and the "I.B. Diffusion" trademark in Canada bearing Registration Number 245806 as well as the good will therein, the same to be held and enjoyed by Regent as fully and entirely as the same


would have been enjoyed by Assignors if this assignment had not been made, including the right to renew the registrations and to sue for past damages.



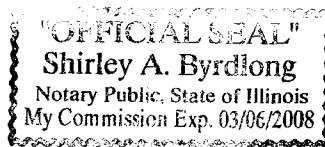


