DECLARATION IN SUPPORT OF CORRECTION TO ASSIGNMENT RECORD

1. I, the undersigned, am Irene Chau, Vice President of Tide Mark Enterprise Limited. The following statements are based on my own personal knowledge of the relevant facts and information.
2. Tide Mark Enterprise Limited (hereafter referred to as "Assignee") is the owner of the above referenced mark and corresponding above referenced application by assignment from Hsao-Hsing Chiu, an individual citizen of Taiwan, said assignment having been recorded with the U.S. Patent and Trademark Office at Reel 002673, Frame 0419. 5. In a signed letter to me dated April 29, 2003, assignor Hsao-Hsing Chiu confirmed ownership of the mark and the above corresponding application and provided the correct business address for Assignee at that time:


