Assignor covenants and agrees that it will, at any time upon the request and at the expense of Assignee, execute and deliver any and all papers and do all lawful acts that may be reasonably necessary in the opinion of Assignee's legal counsel, to enable and assist Assignee to establish, maintain and secure title in Assignee, its successors and assigns, including making such title of lawful public record, and perform such other acts as are reasonably necessary to give full force and effect to this Assignment.
